Submit to Capstone International Services (fax: 205-348-5406) with photocopies of your immigration documents: all I-20/DS-2019 forms issued to you, I-94 Departure Record, current visa, passport expiration and biographical pages. 2) Transfer of the SEVIS electronic record to UA. CIS cannot issue an immigration document before these requirements are met.
